TERMS of SALE: I understand that I am purchasing a puppy that is suitable for a companion or obedience dog only and that the seller does not imply in any way that this puppy is "show quality" The seller does not guarantee the size or of this puppy when full grown as there is no way to predict the final weight or height. Seller also does not guarantee color of puppy upon maturity. _____initial.

HEALTH GUARANTEE: I understand that I am purchasing a puppy that has not had it's final set of vaccinations and that it is my responsibility to continue with the necessary health care as recommended by a licensed veterinarian. I am aware that it is very important to keep my new puppy in a controlled environment until the vaccination schedule has been completed or until recommended by my veterinarian. Seller will not be held responsible for Parvo or Distemper viruses after 48hrs of sale. I understand that parasites and viral infections can be contracted immediately by taking my puppy out to public places and I agree not to hold the seller responsible for any illness incurred by my failure to use common sense in protecting my new puppy's health. _____initial.

I have read and understand the information regarding Hypoglycemia that has been provided in my new puppy's information packet. Seller will not be held responsible for illness or death due to Hypoglycemia! _____initial.

ARF's guarantees that your new puppy has received all vaccinations and other treatments that have been notated on the Health Certificate. I understand that I, the buyer, am required to have my puppy examined by a licensed veterinarian within three business days of taking possession of my new puppy and that failure to do so renders any and all health guarantees null and void. _____initial.

If during your puppy's post purchase examination a life threatening congenital defect (kidney/lungs/heart) is discovered the buyer must contact the seller within 24hrs of the diagnosis and return the puppy to the seller along with all original paperwork. The puppy must be returned with a signed document from the veterinarian stating the defect and it will need to be discussed with a veterinarian of the seller's choice before any refund/exchange is granted. If the replacement option is exercised, the buyer will receive a puppy of equal value and same sex. Replacement puppy will be subject to availability (within 12 months) . The replacement option is only available if the puppy is diagnosed with a genetic/hereditary defect that is of such severity that it renders the puppy unsuitable as a pet. _____initial.

Upon examination by our Veterinarian if the puppy is found to have a condition that is determined not to be genetic or has been caused by neglect or trauma of any kind the guarantee immediately becomes null and void and no replacement, refunds, or reimbursement of medical expenses will be given. _____initial.

Any and all guarantees are solely for the original purchaser of the above described puppy. Puppy is guaranteed from birth to one year of age only. Any transfer of ownership of said puppy renders all guarantees null and void. Buyer understands that puppy must be properly cared for mentally, physically, and medically at all times and agrees to provide proof of all routine medical care from a licensed veterinarian before any disputes can be resolved. _____initial.

I understand that if my new puppy does not work out for any reason there will be no refund given. There will be no refunds due to incompatibility, allergies, buyers remorse, and/or landlord disputes. In the event that I (the buyer) can no longer keep my puppy for any reason I understand that ARF's will take my puppy back no questions asked and that all health records and original registration papers must be returned as well. _____initial.
